Criminal Defence

Alexandra's criminal practice encompasses exclusively defence work. She acts in cases involving serious violence, drugs supply and serious, sexual offences. She has also acted in a number of terrorism related matters and was instructed as junior counsel in the trial of Erol Incedal and Mounir Rarmoul-Bohadjar accused of serious terrorist offences. Following an unprecedented Court of Appeal decision the core of the trial was held in secret on the grounds of national security.

Criminal Regulatory

Alexandra has developed a recognised expertise in criminal regulatory matters relating to breaches of Health & Safety, Food Safety and Fire Safety legislation.

In the Health and Safety field, her practice covers the full range of offences from corporate to gross negligence manslaughter to prosecutions under the Health and Safety at Work Act etc 1974 arising from fatal and non-fatal accidents. She also advises and acts in relation to appeals against Enforcement and Prohibition Notices as well a substantives appeals against conviction and sentence in the Crown Court and the Court of Appeal.

Alexandra has acted for clients, both individuals and corporate entities, across a wide range of industries including Energy, Utilities, Construction, Manufacturing, Agriculture and Food. She is regularly instructed in inquests which often precede prosecutions for H&S offences by the HSE.

Notable & Recent Cases:

Police Investigation and Inquests touching the deaths of Rebecca Ikumelo and Gaby Hutchinson

Acting on behalf of the operators of the Brixton Academy in relation to the deaths of Rebecca Ikumelo and Gaby Hutchinson at a concert on 22 December 2022.

Office for Product Safety and Standards v Sunseeker International Limited

Acting in relation to the prosecution of Sunseeker International Limited for breaches of the Timber and Timber Products (Placing on the Market) Regulations 2013 concerning teak products incorporated into yachts worth approximately £97M.

London Borough of Waltham Forest v SBL

Acting on behalf of a prestigious, independent brewery and bar in relation to a prosecution for breaches of the Food Safety and Hygiene (England) Regulations 2013.

Court of Appeal - R v Places For People Homes ([2021] EWCA Crim 410)

Acted in appeal against sentence for an offence contrary to section 2 of the Health and Safety at Work etc Act 1974 (HSWA) in relation to the use of vibrating tools by employees. It was argued on behalf of the Appellant that in applying Step 4 of the Sentencing Guidelines the Appellant should have been treated in the same way as a charity and therefore entitled to a substantial reduction in fine, in excess of the £350,000 figure the sentencing judge had allowed. The Court of Appeal held that a Community Benefit Society is equivalent to a charity and it should be entitled to a substantial reduction of fine as indicated at Step 4 of the Sentencing Guidelines. Accordingly, the fine was reduced by £200,000 resulting in an overall reduction on the basis of Step 4 considerations of £550,000.

HSE v PFPH

Defended in prosecution of charitable body for breaches of Health & Safety legislation relating to the use of vibrating tools and appeared in appeal above.

HSE v NG

Defended in prosecution of power company for breaches of Health & Safety legislation in relation to gas safety in HRMOBs.

Grenfell Tower Public Inquiry

Acting in relation to the Public Inquiry into the Grenfell Tower fire which resulted in the deaths of 71 people on 14th June 2017.

Westminster City Council (Environmental Health) v SH

Defended a renowned private members club in respect of a Food Safety and Hygiene prosecution.

Westminster City Council (Environmental Health) v CN

Defended a well-known coffee chain in respect of a Food Safety and Hygiene prosecution.

Didcot A Power Station

Advising in respect of the ongoing joint Thames Valley police and HSE investigation into the premature collapse at Didcot A Power Station which resulted in the deaths of four men on 23rd February 2016.

Acting on behalf of FC Nantes in the inquest into the death of 28 year old footballer, Emiliano Sala, who died when the Piper Malibu aircraft he was travelling in crashed into the English Channel, north of Guernsey, in January 2019.

British Virgin Islands Commission of Inquiry

Acting as Junior Counsel to the Commission of Inquiry which was established in January 2021 by the Governor of the British Virgin Islands. The Right Honourable, Sir Gary Hickinbottom, a member of the Court of Appeal, has been appointed as the sole Commissioner of the Inquiry. The purpose of the Commission is to examine the Territory's governance and to make recommendations for improvements. The inquiry is expected to report within six months.

Inquest into the death of Baby C

Acting on behalf of Doncaster & Bassetlaw NHS Foundation Trust in relation to the death of Baby C, a neonate who died in hospital from Necrotising Enterocolitis.

Inquests touching the deaths of Benjamin Haddon-Cave and Patrick Bolster

Acting on behalf of Network Rail in relation to the deaths of Benjamin Haddon Cave and Patrick Bolster who had accessed train track and climbed on top of a freight train in the early hours of the morning of 21 March 2019 and come into contact with the overhead, high voltage power line.

Inquest touching the death of Kishorkumar Patel

Acting on behalf of RATP Dev, one of London's largest providers of bus services. Mr Patel was a London bus driver for RATP Dev. He contracted Covid 19 in April 2020 and died at a Nightingale hospital some 4 weeks later. One of the issues explored by the inquest was the adequacy of protective measures implemented by RATP Dev in relation to Mr Patel in response to the Covid 19 pandemic and by extension the many hundreds of its bus drivers who, as key workers, continued to work throughout the duration of the pandemic.

Manchester Arena Bombing Public Inquiry

Acted on behalf of Showsec in relation to the public inquiry into the Manchester Arena bombing on 22 May 2017 which resulted in the deaths of 22 people.

Inquest touching the death of Roy Morris

Acted on behalf of Oxford NHS Foundation trust in the inquest into the death of a psychiatric patient following his treatment and discharge from hospital.

Inquest touching the death of Charnelle Williams

Representing a station Supervisor in the inquest into the death of a young woman who fell on the tracks (a fall visible from several CCTV cameras) and died from multiple injuries sustained by a passing train several minutes after her fall.

Grenfell Tower Public Inquiry

Acted on behalf of Harley Facades in relation to the public inquiry into the Grenfell Tower fire which resulted in the deaths of 71 people on 14th June 2017.

Inquest touching the deaths of Corporal Matthew Hatfield and Corporal Darren Neilson, Royal Tank Regiment
