She also has experience in serious cases that she has been instructed in alone, including representing one of seven defendants in a three month boiler room fraud trial and the first defendant in a complex money laundering case. She is currently instructed in two lengthy upcoming Trading Standards fraud cases involving multiple defendants, complex legal argument and cross examination of expert witnesses. She is instructed to represent one of nine defendants in a s.18 GBH case involving a stabbing, a young defendant accused of rape and a defendant accused of child abduction.

Grace also has experience in private prosecutions and is an active member of the Private Prosecutors' Association. She was recently involved in providing a complex and substantial advice on the prospects of successfully prosecuting a government official for perjury and perverting the course of justice.

She made important contributions to the lengthy report published at the end of the review.

She has also contributed to a sensitive disclosure exercise in relation to the inquest into the Manchester Arena attack and was instructed in the Independent Inquiry into Child Sexual Abuse.

Criminal Defence

Grace specialises in criminal defence. Her experience extends across the spectrum of criminal law.

She has advised and represented clients accused of serious violence, serious drug supply, sexual offences and fraud. She has experience is navigating the complexities and tactical demands of multi-handed criminal cases, including through acting for those appearing first on the indictment at trial.

She has been recognised as a passionate and persuasive defence advocate with a strong work ethic.

Notable Cases:

R v H and 2 others (2020)

Grace is currently being led by a QC in a multi-handed murder case due to last five weeks. The case has received media attention.

R v R and 2 others (2020)

Grace is currently instructed as sole counsel on behalf of a businessman accused of fraudulent trading. The case involves allegations spanning across three companies and requires detailed analysis of extensive business records.

R v O and 7 others (2020)

Grace is currently being led by a QC in a multi-handed drug supply case. Grace is representing the second defendant who is accused of playing a leading role in a conspiracy to supply of Class A drugs across county lines. The case has involved analysis of extensive cell site, video surveillance and audio probe evidence.

R v I and 6 others (2019)

Grace was recently led in a multi-handed commercial fraud case, valued at over £1 million. Grace acted for the second defendant, a businessman accused of playing a leading role in a conspiracy to commit fraud and money laundering. The first defendant and Grace’s client were involved in a “cut-throat” defence, requiring careful tactical decisions throughout. The case involved analysis of thousands of pages of evidence. Grace was trusted to mitigate on behalf of the defendant at sentence.

Grace was instructed as sole counsel on behalf of a defendant accused of participating in a multi-handed fraud and money-laundering conspiracy. The fraud was valued at £800,000 and the trial lasted 10 weeks. The case involved multiple defendants and Grace navigated a potential “cut-throat” conflict between her client and the first defendant, who was represented by a silk and a junior. The defence involved mastering extensive financial and documentary evidence, and cross-examination of a vulnerable witness. The case attracted media attention.

R v A and 2 others (2018)

Grace was instructed as sole counsel to represent a defendant accused of fraud in relation to construction work. Grace’s client was the first of three defendants on the indictment. The success of the defence turned on the difficult cross-examinations of a vulnerable complainant and an expert witness.

R v S (2018)

Grace was instructed as sole counsel to represent a man accused of an offence under s. 66 of the Sexual Offences Act 2003. Grace’s client had a number of mental health conditions and the case required careful handling of the defendant’s own evidence and a robust cross-examination of Prosecution witnesses.

R v C (2017)

Grace was instructed as sole junior to represent a mother of two accused of supplying a large quantity of Class A drugs. Grace engaged in robust legal argument around a complex issue relating to the law on “intent” and “knowledge” in the context of drug supply that ultimately led to favorable directions being put before the jury.

Private Prosecution

Grace is experienced in private prosecutions.

She has been sought after to advise individuals and entities at the early stages of private prosecutions, and to represent them at trial and in sentence hearings.

She is a member of the Private Prosecutors’ Association and in 2020 she contributed to the *Consultation on Revisions to the Attorney General’s Guidelines on Disclosure and the CPIA Code of Practice* as a member of the Private Prosecutors’ Association Working Group.

She has recently written an article on the hurdles and opportunities faced by private prosecutors in relation to investigatory powers.

Notable Cases:

B v B and Others (2019)

Grace was recently led by a QC and a junior to advise an individual on the prospects of bringing a private prosecution against a government official. The case involved allegations of perjury and perverting the course of justice. The case required an extensive review of over one hundred files of evidence, careful consideration of potential avenues for obtaining further evidence and a detailed written advice on the prospects of success.

involving allegations of fraud and other serious dishonesty. She has been asked to advise in relation to potential charges and has been instructed in private prosecutions at trial and at sentence.

Professional Discipline

Inquests:

Notable Cases:

Inquest into the Death of H (representing Nurse A) (2018)

Grace was instructed to represent a nurse in an inquest involving the death of a patient who had absconded from a psychiatric hospital. Her client was at risk of serious criticism, a situation which Grace navigated with great care. The inquest lasted two weeks and involved complex legal arguments relating to causation.

Inquiries and Investigations:
