prosecuted offences of mortgage fraud, money laundering and fraud by employees. Howard is well versed in the wide spectrum of prosecutions brought by local authorities having dealt with cases from unlawful eviction to compliance with complex European machinery safety regulations and planning enforcement.

## Notable Cases:

### Operation Honda

Acting for the Prosecution in a conspiracy to commit mortgage fraud involving a mortgage broker, conveyancer and other professionals.

### R v El-Kaissi

Prosecuting a multi-agency identity fraud on behalf of the DWP, two London Local Authorities, the Home Office and Passport Office resulting in a seven-year sentence of imprisonment and confiscation order of hundreds of thousands of pounds.

### R v Reid

Prosecuting a model for a high value benefit fraud that received international media attention.

### HMRC v X

Representing HMRC in a case concerning allegations of breaches of the Money Laundering Regulations by an international money services bureau.

### FCA v X

Leading independent disclosure counsel to the FCA in an ongoing investigation into a major fraud at a hedge fund.

## Tax

---

Howard has a significant indirect tax practice, specialising in VAT, excise and other customs duties. Howard's tax practice sees him regularly instructed in the Tax Tribunals and Administrative Court.

Howard has advised on and appeared in cases concerning: penalties, personal liability notices, protective costs orders, the default surcharge regime, VAT treatment of charities, zero rating of construction supplies, VAT applicable to clothing, the impact of human rights on tax litigation, excise duties arising from failure to follow customs procedures and customs powers.

## Recent cases:

### **Eynsham Cricket Club v The Commissioners for Her Majesty's Revenue & Customs [2021] EWCA Civ 225**

The case was brought following HMRC's ruling that the Club's construction of a new cricket pavilion could not be zero-rated for VAT because, as a CASC, it could not benefit from the VAT relief provided specifically for charities.

### **Drummond v Revenue and Customs [2016] UKUT 221 (TCC)**

The leading case on protective costs orders in the Tax Tribunals.

### **St George's Augustinian Care v Revenue and Customs [2016] UKFTT 567 (TC)**

Acting for HMRC in a case concerning the zero-rating treatment of the construction of a retirement village.

### **HMRC v Ebuyer & Citibank, Fonecomp [2015] EWCA Civ 39 and Davis and Dann Ltd [2016] EWCA Civ 142**

Acting for HMRC in the three civil MTIC fraud cases to have reached the Court of Appeal in recent years.

### **HMRC v X**

Acting for HMRC in a high-profile direct and indirect tax case arising out of a COP9 procedure.

### **HMRC v H**

Acting for HMRC in a case concerning one of the largest Personal Liability Notices ever issued to a company director.

## Criminal Defence

---

Howard Defends, mainly in relation to serious allegations of financial wrongdoing, at all levels of Court.

### Recent Cases:

#### **R v A**

Howard was instructed, pre-charge, to defend the Managing Director of a claims handling company who was said to be at the centre of one of the largest "cash for crash" conspiracies in the North East. In a related judicial review conducted by Howard the Court and Police eventually accepted that the warrants under which they had searched the client's home and business addresses and uplifted significant evidence were unlawful. Howard's client was ultimately not charged.

#### **R v AA**

Howard was instructed in the successful defence of a client accused of being part of a conspiracy to hi-jack minicabs involving some 30 individual hi-jackings.

## Criminal Regulatory

---

Howard is a member of the panel of Specialist Regulatory Advocates in Health and Safety and Environmental Law, maintained by the HSE.

Howard is experienced in both advisory and advocacy work in regulatory cases concerning: health and safety, food hygiene, trading standards, consumer protection, advertising, planning enforcement, noise nuisance, trademark and copyright infringement, compliance with the Money Laundering Regulations and compliance with Charity Commission requirements.

Howard was instructed in the health and safety prosecution of a British Gas employee alleged to have caused a release of asbestos in a retail premises during the course of his work.

### **R v R & R**

Howard was instructed in the first prosecution of an HMO licence holder and manager for breaches of the HMO Regulations. This case involved complex arguments on the interpretation of the Regulations which had not previously been before a court.

### **R x HQPEL**

Howard was instructed in the prosecution of a multi-national concrete company for breaches of its environmental permit conditions. HQPEL was a very large organisation for the purposes of the new sentencing guidelines.

### **R v CBL**

Howard was instructed in the prosecution of a basement conversion company for breaches of regulations in relation to advertisements.

### **R v JS**

Howard was instructed in the prosecution of a developer for breaches of planning enforcement notices.

## Private Prosecution
